

**ANNOUNCEMENT AFTER THE PRESS CONFERENCE OF THE NATIONAL
ELECTORAL COMMISSION HELD ON
8 JUNE 2009 AT 7.40CET AT THE NEC'S HEADQUARTERS.**

On 8 June 2009 at 7:40CET a press conference concerning the European Parliament Elections 2009 was held at the headquarters of the National Electoral Commission.

During the press conference, NEC's Chairman, Judge Ferdynand Rymarz announced partial unofficial results of the vote and the predicted distribution of mandates in the elections to the European Parliament as at 7:40 CET on 8 June 2009.

On the basis of the data received electronically on the results of the vote in 25 323 polling stations, out of the total number of 25 605 polling stations, i.e. 82,38%, the partial unofficial results of the election with regard to the number of votes cast on the individual electoral committees and the forecast distribution of mandates between electoral committees determined on the basis of the data from these polling stations are as follows:

Number of eligible voters: 30 207 028;
Number of voters who participated in the election: 7 409 941;
Turnout: 24,53%;
Number of valid votes cast on all district lists in the country: 7 278 781;
Number of valid votes cast on individual district lists was as follows:

Assuming that the above data constitute the basis for determining the results of the election, the following electoral committees, all of which obtained a minimum of 5% of the votes valid countrywide, would be entitled to participate in the distribution of mandates:

In conclusion Chairman Rymarz informed the journalists that the counting continues in accordance with the schedule. Rzeszów, Gdańsk, Bydgoszcz, and Warszawa 2 constituencies have already provided 100% of the reports. At the moment the data loaded into the system are verified. In response to the journalist queries, Judge Ferdynand Rymarz said that as at that moment the names of all the candidates who obtained eurodeputy mandates could not be disclosed. The process of mandate allocation has four stages and has not been completed as yet. This is the last conference on the partial unofficial results; the next conference will be held after 100% of the votes have been counted. The total election turnout will also be provided during that conference,
